Code of conduct for the students of DIU

1. Principles

This Code of Conduct has been formulated to provide a clear statement of the University's expectations of students in respect of academic matters and personal behavior.

Study at the University presents opportunities for interacting with other members of the University community. The University recognizes and values the diversity of student experiences and expectations, and is committed to treating students, both academically and personally, in a fair and transparent manner. All students, in return, are required to comply with the requirements set down in this Code of Conduct.

Daffodil International University reaffirms its commitment to:

- High academic standards, intellectual rigor and a high-quality education;
- Intellectual freedom and social responsibility;
- Recognition of the importance of ideas and the pursuit of critical and open inquiry;
- Tolerance, honesty and respect of relationships throughout the University community; and
- High standards of ethical behavior.

All students are required to be aware of and act consistently with these values.

2. Coverage

This Code of Conduct applies to all students of the Daffodil International University, in respect of all actions and activities relating to or impacting on the University or its students and employees. It must be read in conjunction with the statutes, rules, and resolutions of the University.

3. Definitions

In this Code of Conduct the following affairs may be indulged:

University: Daffodil International University

Student means all students of the Daffodil International University, including exchange students, DIL students, Summer Exchange program etc.

Employee means all staff of the Daffodil International University, (including full-time, part-time or

Contractual). Suspension: Written notification to the student explaining that she/he has been suspended from the university for a certain period of time and s/he is not allowed to attend classes or examinations during this period of time.

Warning: Written notification to the students explaining that he /she is to be more careful about his/her duties and behavior related to being a student.

Expulsion from University: Written notification to the student explaining that she/he has been expelled from the university.

- a. Expulsion may be for a certain period (one semester/two semesters or more) and she/he is not allowed to attend classes or examinations during this period of time and he/she is not to exercise any of his/her rights as a student during the period of time. Another
- b. Expulsion is for good i.e Permanent Expulsion: In this case the student will be ineligible to be admitted in this university anytime in future.

Student Code of Conduct

Personal conduct

All students must:

- treat all employees, honorary appointees, consultants, contractors, volunteers any other members of the public and other students with respect, dignity, impartiality, courtesy and sensitivity;
- maintain a cooperative and collaborative approach to inter-personal relationships;
- act honestly and ethically in their dealings with others.
- respect the privacy of everybody.
- ensure that they do not act in a manner that unnecessarily or unreasonably impedes the ability of employees, honorary appointees, consultants, contractors, volunteers any other members of the public and other students to carry out their study, research or work at the University, to access or use the resources of the University including in the Library, Lecture theatres and Laboratories;
- ensure that they do not become involved in or encourage discrimination against or harassment or bullying of employees, honorary appointees, consultants, contractors, volunteers any other members of the public or other students.

Academic Conduct

All students must:

- ensure that their enrolment and progress in their awarded course is lawful and consistent with the rule and resolutions of the Daffodil International University. Students must not enroll with other University at the same time with this University.
- read all official correspondence from the University, including email;
- act ethically and honestly in the preparation, conduct, submission and publication of academic work, and during all forms of assessment, including formal examinations and informal tests;
- avoid any activity or behavior that would unfairly advantage or disadvantage another student academically;
- conform to the University's requirements for working with others.

Discipline is an important aspect of Daffodil International University (DIU). The University serves as an instrument for molding the character and behavior of the student and this prepares them to take up their future careers as well as the mantle of leadership. Also it is generally accepted that is education constitutes the single most important instrument for the acquisition of knowledge and skills that indispensable for the building of manpower base to promote socioeconomic advancement.

Therefore, DIU has formulated above code of conducts. If students violate those, university will take preventive measure and also will hand in punishment to offenders to maintain peace and academic environment of the university. Punishment may be warnings, expulsion for one or more semester or expelled for good from the university depending on the gravity of the offence. Guardians will be involved in this process.
